

OFFICIAL CONTEST RULES AND REGULATIONS

Bobcaygeon Contest ('Contest')

Contest Rules & Regulations ('Contest Rules')

September 26, 2025 to December 18, 2025

CONTEST: Three (3) PRIZES comprised of \$200 Visa gift cards.

WHO CAN ENTER: This Contest is open to property owners in the Bobcaygeon community who are at least 18 years old at the time of entry. **Only one entry per household is permitted.** Employees of Enbridge Gas, its subsidiaries and affiliated companies and each of their respective directors, officers, employees, agents, representatives, advertising or promotional agencies, members of their immediate families and persons with whom any of the foregoing are domiciled are not eligible.

CONTEST PERIOD: The Contest starts on September 26, 2025, and closes on December 18, 2025 at 11:59 am EST (the '**Close Date**'). The period in which the Contest is open to entrants from September 26, 2025, until the Close Date is referred to as the '**Contest Period**'.

HOW TO ENTER: NO PURCHASE NECESSARY. Speak with an Enbridge Gas representative and fill out a ballot to enter into a prize draw for one of three (3) \$200 Visa gift cards. The draw will be held on December 18, 2025 (the '**Draw Date**')

Enbridge Gas is not responsible for lost, late, damaged, illegible, stolen, misdirected, misidentified or incomplete entries, for any problems or technical or mechanical malfunction of any telephone systems, computer on-line systems, servers, access providers, computer equipment, software, failure of any entry to be received by Enbridge Gas on account of technical problems or traffic congestion on the Internet or at any website, or inaccurate entry information, whether caused by equipment, programming used in this Contest, human processing or otherwise, or any combination thereof.

PRIZES: There are three (3) prizes to be won, comprised of \$200 (two hundred dollar) Visa gift cards. The draw will take place on December 18, 2025 at the Enbridge Gas storefront, 71 Bolton St, Bobcaygeon, ON, K0M 1A0. All entries must be received by 11:59 am EST on December 18, 2025 to be eligible for the Prize draw.

Prizes are non-transferable and non-assignable. No substitution of prizes is permitted except by Enbridge Gas. All prizes will be awarded. The odds of winning are dependent upon the number of eligible entries received by the applicable Draw Date.

RANDOM DRAW: Three (3) names will be selected in a random draw on the specified date from among all eligible entries received for the Contest during the Contest Period by the applicable Draw Date. Enbridge Gas reserves the right to require proof of age and jurisdiction of residence prior to awarding any Prize. Enbridge Gas will also draw two additional names solely for use in case the previous selected entrant for such Draw Date is ineligible to win the Prize.

WINNER NOTIFICATION: Selected entrant will be notified by email or phone within 4 weeks of the Draw Date. Selected entrant will be required to acknowledge by phone or email his or her eligibility for the Prize, correctly answer a mathematical skill-testing question, and sign an affidavit and return it to Enbridge Gas (Enbridge Gas Marketing Department; 500 Consumers Rd, North York, ON M2J 1P8) or via email within ten (10) business days of the date on which the notification is sent to the selected entrant for signing. If no response is received by Enbridge within ten (10) business days of the date on which the notification is

sent, the Prize will be forfeited and may be awarded to an alternate selected entrant in a random draw that has been drawn from the remaining eligible entries for that Draw Date.
